- Work completed by a governmental subdivision or state agency costing less than \$15,000.00

VII. Fee Clarifications

ITEM # 2: SERVICE FEE: WHEN RE-ENERGIZING AN EXISTING SERVICE, ONLY AN APPLICATION FEE AND SERVICE FEE IS REQUIRED.

ITEM #17, MOBILE HOME SITE:

When installing a site service in a park, the permit application must include the application fee, service, plus the number of park sites, and final inspection. When installing a HUD mobile home in a park, a permit must include the application fee, a feeder, and a final inspection. This shall be done by a licensed electrical contractor. When installing a HUD mobile home or a pre-manufactured home on private property, a permit must include the application fee, service, feeder, and a final inspection.

IX. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Electrical work shall not be started until the application for permit has been filed at the Benton Charter Township Hall. All installations shall be in conformance with the **2023 Michigan Electrical Code**. **No work shall be concealed until it has been inspected.**

When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number. The phone number for the Inspector is provided on the header of this application and on the permit. The permit will be mailed to you.

IF THE APPLICANT IS NOT THE INDIVIDUAL ON SITE COMPLETING THE WORK, THE PERMIT WILL BE REVOKED.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.
